In pursuance of the result of Assistant Review Officer Examination-2014, a temporary appointment on the post of **Assistant Review Officer** in the Establishment of the High Court at Allahabad in the pay scale of P.B.-2 Rs. 9,300-34,800, Grade Pay Rs. 4,600 per mensem plus usual allowances is hereby offered. Your appointment will be liable to be terminated at any time as per rules. If you are willing to accept the offer, you should report for duty to the undersigned **within 15 days from the issue of this appointment letter**, failing which your claim for appointment on the said post will be ceased automatically.

You will be on probation for one year as per rules. Your appointment on the post of Assistant Review Officer shall be subject to the outcome of writ petition/s and/or appeal/s (if any) pending in the High Court and/or in Hon'ble The Supreme Court in this matter and Character and Address verification report obtained from the police department. The verification of following original testimonials / certificates will be done at the time of joining :

- I. High School;
- II. Intermediate;
- III. Graduation;
- IV. Post-graduation (if applicable);
- V. Diploma / Degree in Computer Science from a recognized Institution/University, 'O' level certificate awarded by DOEACC Society, 'CCC' in computer science from recognized institute established by law in India;
- VI. Domicile Certificate (only for reserved category candidates of U.P.)
- VII. Caste Certificate (only for reserved category candidates of U.P.)
- VIII. No Objection Certificate & relieving request (only for Central/State Government / P.S.U. Employees)
- IX. Discharge Certificate (only for Ex-servicemen of Navy/Naval Academy, Army and Air Force service)
- X. Certificate in favor of Sports Person.
- XI. Disability Certificate in favor of Disabled person.
- XII. Identity Card issued by competent authority.

At the time of verification, it is obligatory on your part to satisfy the competent authority about your candidature by providing the required original documents before joining. You should have to provide such documents which prove the recognition of the institute from which the Diploma or Certificate in computers has been obtained by you. If you would not be able to satisfy the authority, your candidature may be forfeited by the appointing authority.

You must submit following documents at the time of joining in the establishment of the High Court :


1. **Two Character Certificates from the Members of Parliament or State Legislature or Gazetted Officer to the effect that you bear a good moral character and have never taken part in any act subversive of law and order.**
2. **A Medical Certificate from the Chief Medical Officer of your district to the effect that you are in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of your official duties.**
3. **A declaration on affidavit on Stamp Paper of Rs. 10/- also be furnished to the effect that you are neither a previous convict nor any criminal case is pending before any Court of Law nor any F.I.R. has been lodged against you.**
