2. The Division Bench matters and Single Bench matters pertaining to Leave to Appeal (Application) U/s 372 and U/s 378 Cr.P.C. shall be placed on regular basis, strictly starting from the oldest, before the Benches concerned as per Constitution of Special Benches.
3. On account of recent spike in the number of COVID-19 positive cases at Prayagraj, the Constitution of Benches w.e.f. 3<sup>rd</sup> of January, 2022 (as modified time to time) shall remain inoperative for the period of this Constitution of Special Benches, until further orders.
4. Due to COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
5. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
