

Instructions

Qualification: A person **shall not be qualified** for appointment as a Special Judicial Magistrate unless he/she:-

- (a) holds or has held any post under the Government;
and
- (b) possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court.

Term of Office: The term of the office as Special Judicial Magistrate/Special Metropolitan Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

Documents required with application: All the applicants shall submit their applications containing self-attested xerox copies of the documents of the particulars mentioned in the application alongwith the photocopies of character roll entries of the last 5 years of their Government Job.

Submission of Form: All the applicants shall submit their applications alongwith all the relevant documents to the District Court(s) of the district(s) for which they are applying for the post of SJM/SMM. The District Judge(s) after proper scrutiny shall only forward those applications to the High Court which he finds fit for the post of SJM/SMM alongwith his remarks without any delay.
