**Note:-**

1. The Administrative Order dated 16.12.2013 regarding part heard and tied up cases will continue in operation.
2. **Fresh cases beyond Serial No. 125 and Additional/Unlisted cases beyond Serial No. 3125, will not be taken up in any Court (except date fixed matters) but will be rotated in due course.**
3. Mentioning, if any of Single Bench cases shall be made before the Senior most Single Bench available among all the Benches having the jurisdiction over the matter as per the Constitution of Benches except Part Heard and Tied Up matters.
4. Mentioning, if any of Division Bench cases shall be made before the Senior most Division Bench available for Civil matters for Division Bench Civil cases and Senior most Division Bench available for Criminal matters for Division Bench Criminal cases as per the Constitution of Benches except Part Heard and Tied Up matters.
5. Mentioning of any cases pertaining to jurisdiction specially assigned to any Court shall be made before such court except Part Heard and Tied Up matters.
6. Criminal Appeals of the Convicts in Custody for more than seven years shall be listed at the Top of the List for priority hearing.
7. Priority hearing of all Supreme Court Expedited matters.
8. Priority hearing of old criminal matters for final disposal, Capital Sentence cases , criminal appeals where the accused has undergone more than half the sentence in view of Section 436A Cr.P.C. and the accused is in jail.
9. Priority hearing of matters relating to murder, rape, dacoity and kidnapping.

10. Priority hearing of those cases wherein mediation is successful.
11. Priority hearing of Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015 and Habeas Corpus Writs.
