With reference to his/her application in response to **Advertisement No. 02/Law Clerks (Trainee)/2023** for being considered for the post of Law Clerk (Trainee) (now re-designated as **Research Associate**) in the High Court of Judicature at Allahabad, he/she is hereby informed that he/she has been selected as a Research Associate to be attached with Hon'ble Judge on a fixed honorarium of **Rs. 25,000/-** per month with no other allowances and without any other perquisite such as residential accommodation etc. The engagement shall be purely short-term contractual basis initially for the duration of one year which is liable to be extended further for upto one more year subject to his/her performance being found to the satisfaction of the Hon'ble Judge with whom he/she is attached. However, the term may be changed/terminated at any time, without any notice.

It is made clear to him/her that the above short term engagement shall not confer upon him/her any right to claim regular appointment like other appointees in the Registry. The said engagement shall be subject to the following conditions :-

1. That from the date of completion of his/her engagement as Research Associate, he/she shall not appear or practice for a period of one year before the Hon'ble Judge (s) with whom he/she was attached.
2. He/She shall not appear in any case handled by the Hon'ble Judge (s) with whom he/she had remained attached, irrespective whether he/she had or had not worked on that case during the period of his/her engagement.
3. In case of his/her being enrolled as an Advocate, he/she shall furnish an undertaking that he/she has surrendered his/her registration for a period of one year till he/she remains engaged as a Research Associate.
4. He/She shall be governed by such rules of attendance, leave and other related matter as might be prescribed from time to time by Hon'ble the Chief Justice of High Court of Judicature at Allahabad.
5. After three months from date of joining, performance and work done by the Research Associate will be reviewed by Hon'ble Judge with whom he/she is attached/Ld. Registrar General and if the performance/work is not found satisfactory, the engagement will be cancelled.

If he/she is willing to accept the above terms and conditions to be engaged as a Research Associate, he/she may report for joining in the Establishment Section of this Hon'ble Court from 06.03.2024 to 16.03.2024.
