- 1. In view of pandemic of COVID-19, the roster w.e.f. 20.01.2020 shall remain inoperative till further orders.
- 2. All fresh matters may be filed in e-mode or in physical form, without any urgency application.
- 3. W.e.f. 6<sup>th</sup> of July, 2020, urgency applications for hearing of LISTED matters may be filed in physical form in Application Section and such applications will be placed before Hon'ble Court having jurisdiction over the matter in effective Constitution of Special Benches as on date, provided Urgency/Listing/other likewise applications in the TU/PH matters shall be placed before the TU/PH Bench.
- 4. Only those **LISTED** matters shall be listed in Courts, for which urgency applications are allowed by the Court; except Listed Single Bench Criminal Appeals up to the year 1990 and all application under Section 11 of the Arbitration and Conciliation Act, 1996, which shall be listed as per this Constitution of Special Benches without requirement of any urgency applications. Such matters shall be listed only in Additional Cause List.
- 5. The Daily Cause List shall not be printed/published till further orders.
- 6. All matters assigned from 20.01.2020 to 18.03.2020, except nominated and/or tied up/part heard, be placed before respective Courts as per Constitution of Special Benches at Allahabad, notified time to time in view of pandemic of COVID-19.
- 7. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
