7. Priority hearing of Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015.
8. There shall be **no requirement of Urgency Applications** in **Fresh** and **Listed** matters.
9. Due to the COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
10. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
