2. During Summer Vacation, in the absence of the Senior Vacation Judge, the next Senior most Vacation Judge shall exercise jurisdiction as postulated in Chapter V Rule 10 (2) of the Rules of the Court, 1952, at Allahabad.
3. In Civil cases and Writ Petitions which require immediate attention, as postulated in 2nd part of sub-Rule (1) of Rule 10 of Chapter V of the Rules of the Court, 1952, a separate paragraph showing the urgency be specifically mentioned in the petition itself.
4. Applications regarding urgent hearing of Writ Petitions (excluding Criminal Writs and Habeas Corpus matters, which shall be dealt in Criminal Side) and Cases of Civil nature, during the summer vacation shall be filed before the appropriate Vacation Benches.
5. All left out/passed over fresh Criminal Matters, which could not be taken up prior to the Summer Vacation, will be taken up by the appropriate Vacation Benches during summer Vacation provided that Part Heard and Tied Up matters shall be placed before such Benches, if available.
6. All such Fresh Criminal Matters (including Criminal Writs and Habeas Corpus matters), which could not be taken up prior to the Summer Vacation, will be taken up by the appropriate Vacation Benches during the summer vacation, Part Heard and Tied Up matters shall be placed before such Benches, if available.
7. Mentioning, if any of Division Bench cases shall be made before the Senior most Division Bench available for Civil matters for Division Bench Civil cases and Senior most Division Bench available for Criminal matters for Division Bench Criminal cases as per the Constitution of Benches during Summer Vacation.
8. Mentioning of any cases pertaining to jurisdiction specifically assigned to any Court shall be made before such court except Part Heard and Tied Up matters.
9. Mentioning, if any of Single Bench cases shall be made before the Senior most Single Bench available among all the Benches having the jurisdiction over the matter as per the Constitution of Benches during Summer Vacation.
10. Due to the COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
11. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
