2. **2.** There is no need to file Urgency Application with regard to the matters pertaining to Criminal Misc. Bail Applications, Anticipatory Bail, Criminal Appeal U/s 14 A (2) SC/ST Act, Criminal Revisions filed U/s 102 of the Juvenile Justice Act, 2015, Habeas Corpus Writ Petition, Civil Matters pertaining to demolition, recovery and eviction, writ matters pertaining to Arrest/Stay of Arrest either in fresh cases or filed cases. The aforesaid cases shall be placed before the Hon'ble Court as usual. However, in all other matters (fresh as well as filed), Urgency Application will be filed and these matters shall be placed before the Hon'ble Court only after the Urgency Application is allowed by the Special Benches constituted.
3. **3.** Urgency applications shall be placed before the Bench having Jurisdiction over the matter, provided urgency applications in TU/PH matters shall be placed before the TU/PH Bench.
4. **4.** The Daily Cause-List shall not be printed/published till further orders.
5. **5.** All Cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
6. **6.** The High Court of Judicature at Allahabad, Lucknow Bench, Lucknow shall function in accordance with the modalities and arrangement dated 17-04-2021 and onwards during Covid-19.
