NOTE:

1. The administrative order dated 16-12-2013 regarding part heard and tied up cases will continue in operation.
2. Orders dated 04-12-2018 and 16-01-2019 regarding listing of only listed matters on Wednesdays shall remain in abeyance till further order(s).
3. Priority hearing of those criminal appeals where the accused has undergone more than half the sentence in view of Section 436A Cr.P.C. and the accused is in jail.
4. Priority hearing of matters relating to murder, rape, dacoity and kidnapping.
5. Priority hearing of those cases wherein mediation is successful.
6. Priority hearing of Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015.
7. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
8. Only those **LISTED** matters (except as in para 9, 10 and 11) shall be listed before Hon'ble Courts, for which urgency applications are allowed by the Hon'ble Courts. Such matters shall be listed only in Additional Cause-List.
9. **Listed**, Criminal Cases pertaining to Members of Parliament, Members of Legislative Assembly and Members of Legislative Council **and** Criminal Appeals upto the year 1990, shall be listed, in Additional Cause List, without requirement of Urgency Application(s).
10. Supreme Court Expedited matters shall be listed before Hon'ble Courts without requirement of Urgency Applications.
11. There is no need to file Urgency Application with regard to the **LISTED** matters pertaining to **Criminal Misc. Bail Applications, Anticipatory Bail, Criminal Appeal U/s 14 A (2) SC/ST Act, Criminal Revisions filed U/s 102 of the Juvenile Justice Act, 2015, Habeas Corpus Writ Petition, Writ matters pertaining to Arrest/Stay of Arrest, Civil Matters pertaining to demolition, recovery and eviction**. The aforesaid cases shall be placed before the Hon'ble Court as usual.
12. Urgency applications shall be placed before the Bench having jurisdiction over the matter, provided urgency applications in TU/PH matters shall be placed before the TU/PH Bench.
13. Due to Covid-19 pandemic, the Daily Cause List shall not be printed/published till further orders.
14. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
