All the Officers/Officials of High Court of Judicature at Allahabad (excluding HJS Officers) are hereby directed to comply with the provisions laid down in Rule 24 (3) of the U. P. Government Servant Conduct Rules 1956 relating to declaration of all Movable, Immovable and Valuable Property owned, acquired or inherited by him on lease or mortgage. As per the provision, every Government Servant should state the full particulars of the property, shares and other investments which may from time to time be held or acquired by him or his wife or by any member of his family living with or any way dependent upon him. The excerpts of the given Rule is quoted below:-

"24 (3) "At the time of first appointment and thereafter at intervals of five years, every Government servant shall make to the appointing authority, through the usual channel, a declaration of all immovable property owned, acquired or inherited by him or held by him on lease or mortgage, and of shares and other investments which may from time to time be held or acquired by him or by his wife or by any member of his family living with, or in any way dependent upon him. Such declaration should state the full particulars of the property shares and other investment."

As such all Officers/officials are hereby directed to submit duly filled up proforma of Property Statement preferably within One month from the date of this notice before appropriate authority.

Proforma of Property Statement be furnished held upto financial year 2020-2021 by the Officers/Officials.
