- 1. The Division Bench comprising Hon'ble Mr. Justice Suneet Kumar and Hon'ble Mr. Justice Shiv Shanker Prasad will sit in Court No.42 upto midday recess and again after re-formation of the Division Bench to take up the determination to be taken up there. Hon'ble Mr. Justice Shiv Shanker Prasad will sit singly in Court No.73 after midday recess till the re-formation of Division Bench in Court No.42 and will take up his own determination of Court No.73 (Hon'ble Mr. Justice Shiv Shanker Prasad).

- **6.** In modification of earlier order dated 29.03.2023, Hon'ble Mr. Justice Nalin Kumar Srivastava (Court No.84) in addition to his own determination, will take up the determination of Court No.83 (Hon'ble Mrs. Justice Jyotsna Sharma), which was earlier transferred to Court No.79 (Hon'ble Mr. Justice Krishan Pahal).
- 7. Hon'ble Mr. Justice Kshitij Shailendra (Court No.52) in addition to his own determination, will take up the fresh cases from serial nos.1 to 9, Applications and remaining determination (except the Additional/Unlisted cases from serial nos.3001 to 3067) of Court No.4 (Hon'ble Mr. Justice Jayant Banerii).
