- **3.** In modification of earlier order dated 02.09.2023, Hon'ble Mr. Justice Jayant Banerji (Court No.1) in addition to his own remaining determination, will take up the fresh cases from serial nos.58 to 97 of Court No.1, which were earlier transferred to Court No.2 (Hon'ble Mr. Justice Saral Srivastava).
- **4.** Hon'ble Mr. Justice J. J. Munir (Court No.33) in addition to his own determination, will take up the fresh cases from serial nos.1 to 5, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.2 (Hon'ble Mr. Justice Saral Srivastava).
