#### **General Terms and Conditions:**

- 1. The reference of judgments to-be translated, shall be provided to the empanelled Vetters by the SUVAS Cell at Allahabad.
- After due vetting & corrections, the said Vetters shall return the same, certifying the
  correctness of the translation. Both hard-copy as well as soft-copy of the vetted
  judgment will have to be submitted. Each page of the hard-copy of the vetted translation
  will have to be signed by the Vetter.
- 3. Only Unicode font, viz. Mangal or Lohit will be used in the vetted judgment.
- 4. A disclaimer shall be included in the footer of each page of the vetted judgment. The format of the said disclaimer shall be provided by the SUVAS Cell at Allahabad.
- 5. The bills for payment of remuneration to the concerned Vetter will be submitted to the SUVAS Cell at Allahabad for releasing the payment directly in their respective bank accounts. The bills should contain details such as-Name of Vetter, Bank details (Bank name & branch, IFSC Code, Account type & number), PAN number, Aadhar number and Bar Council/Association Registration number.
