In modification of earlier order dated 02.12.2023, Hon'ble Ms. Justice Nand Prabha Shukla (Court No.82) in addition to her own determination, will take up the fresh cases from serial nos.104 to 205, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.80 (Hon'ble Mr. Justice Subhash Chandra Sharma), which were earlier transferred to Court No.77 (Hon'ble Mrs. Justice Renu Agarwal).

In modification of earlier order dated 02.12.2023, Hon'ble Mr. Justice Vinod Diwakar will sit singly in Court No.88 and will take up the determination (including the fresh cases from serial nos.150 to 199 of Court No.88, which were earlier transferred to Court No.90 (Hon'ble Mr. Justice Dinesh Pathak) and the fresh cases from serial nos.200 to 249 of Court No.88, which were earlier transferred to Court No.92 (Hon'ble Mr. Justice Anish Kumar Gupta) of Court No.88 (Hon'ble Mr. Justice Sanjay Kumar Singh).
