## <u>ARRANGEMENT</u>

- 1. In modification of earlier order dated 08.02.2024, the Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi (Court No.42) in addition to its own remaining determination, will take up the fresh cases from serial nos.102 to 151 of Court No.42 (The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi), which were earlier transferred to Court No.43 (The Division Bench presided over by Hon'ble Mr. Justice Siddhartha Varma).
- 2. In modification of earlier order dated 08.02.2024, the Division Bench presided over by Hon'ble Mr. Justice Ashwani Kumar Mishra (Court No.40) in addition to its own determination, will take up the determination of Court No.44 (The Division Bench presided over by Hon'ble Mr. Justice Arvind Singh Sangwan).
- **3.** In modification of earlier order dated 08.02.2024, the Division Bench presided over by Hon'ble Mr. Justice Siddharth (Court No.46) in addition to its own determination, will take up the Additional/Unlisted cases from serial nos.3052 to 3103 of Court No.67 (The Division Bench presided over by Hon'ble Mr. Justice Rahul Chaturvedi) and will also take up the determination of Court No.43 (The Division Bench presided over by Hon'ble Mr. Justice Siddhartha Varma).
- **4.** Hon'ble Mr. Justice Anish Kumar Gupta will sit singly in Court No.89 and will take up the fresh cases from serial nos.187 to 286 of Court No.87 (Hon'ble Mr. Justice Vivek Varma).
- 5. In modification of earlier order dated 08.02.2024, Hon'ble Mr. Justice Vinod Diwakar will sit singly in Court No.72 and will take up the determination of Court No.72 (Hon'ble Mr. Justice S. A. H. Rizvi) and will also take up the fresh cases from serial nos.112 to 211 of Court No.73 (Hon'ble Mr. Justice Saurabh Srivastava), which were earlier transferred to Court No.72 (Hon'ble Mr. Justice S. A. H. Rizvi).

Note:-

- 1. The condition regarding not taking up the Fresh cases beyond Serial No.125 shall be suspended for 12.02.2024.
- 2. The bar will remain applicable for the Additional/Unlisted cases, meaning thereby that the Additional/Unlisted cases beyond Serial No.3125 will not be taken up in any Court and be rotated in due course (except date-fixed/period-fixed/term-fixed cases, tied-up/part-heard cases and stay extension cases) for 12.02.2024.
