With reference to his/her application in response to *Advertisement No. 01/Law Clerk (Trainee)/17* for being considered for the post of Law Clerk (Trainee) in the High Court of Judicature at Allahabad, he/she is hereby informed that he/she has been selected as a Law Clerk (Trainee) from reserve list, to be attached with an Hon'ble Judge up to **25 October 2018** on a fixed honorarium of **Rs. 12,500/-** with no other allowances and without any other perquisite such as residential accommodation etc. The engagement shall be purely contractual up to 25 October 2018, which may be terminated at any time if the incumbent is found lacking.

It is made clear to him/her that the above short term engagement shall not confer upon him/her any right to claim regular appointment like other appointees in the Registry. The said engagement shall be subject to the following conditions :-

1. That from the date of completion of his/her engagement as Law Clerk (Trainee), he/she shall not appear or practice for a period of one year before the Hon'ble Judge (s) with whom he/she was attached.
2. He/She shall not appear in any case handled by the Hon'ble Judge (s) with whom he/she had remained attached, irrespective whether he/she had or had not worked on that case during the period of his/her engagement.
3. In case of his/her being enrolled as an Advocate, he/she shall furnish an undertaking that he/she has surrendered his/her registration for a period of one year till he/she remains engaged as a Law Clerk.
4. He/She shall be governed by such rules of attendance, leave and other related matter as might be prescribed from time to time by Hon'ble the Chief Justice of High Court of Judicature at Allahabad.
5. His/Her engagement shall be for a fixed term of one year (i.e. up to 25 October 2018) only which may be terminated without notice at any time.

If he/she is willing to accept the above terms and conditions to be engaged as a Law Clerk (Trainee), he/she may report to the undersigned **on or before 08.01.2018** (except winter holidays: from 23.12.2017 to 01.01.2018 ).
