Due to grant of Super Time Pay Scale to some officers and consequent availability of earlier vacancies in Selection Grade Pay Scale, the earlier date of vacancies in Selection Grade Pay Scale mentioned below in column no. 4, which was granted to the officers vide Courts' Notification No. C-610/Cf.(A)/2017 dated 28.03.2017, are now being readjusted as mentioned in column no. 6 against the vacancies mentioned in column no. 7 and in exercise of the powers conferred by Rule 27 of the Uttar Pradesh Higher Judicial Service Rules, 1975 (as amended), all other powers enabling in this behalf and in view of Government Order No. 783/II-4-2010-45 (12)/91 T.C.VI dated 10.04.2010 and G.O.
