- 1. The Senior-most Advocate in the Advocates' Chambers will be the Chief Tenant of the concerned Chambers.
- 2. The Advocates fulfilling following conditions will be eligible to apply for allotment of Seats in Advocates' Chambers at Allahabad -
  - Practice at Principal Seat, Allahabad
  - Possession of valid "Advocates' Roll Number".
- 3. The eligible Advocates will be required to apply on Proforma for Allotment of Advocates' Chambers, which forms part of the instant Resolution.
- 4. The criterion for allotment of Advocates' Chambers will be Seniority.
- 5. The Seniority will be as per the Registration Number in the Bar Council.
