1. **There shall be no sitting of the Courts in the High Court at Allahabad, on 9<sup>th</sup> of October, 2020. The matters date fixed for 9<sup>th</sup> of October, 2020 shall be taken up on 12<sup>th</sup> of October, 2020.**
2. In view of pandemic of COVID-19, **the roster w.e.f. 13.07.2020 shall remain inoperative** till further orders.
3. Only those **LISTED** matters (except Criminal Cases pertaining to Members of Parliament, Members of Legislative Assembly and Members of Legislative Council) shall be listed in Hon'ble Courts, for which urgency applications are allowed by the Hon'ble Courts. Such matters shall be listed only in Additional Cause List.
4. Listed Criminal Cases pertaining to Members of Parliament, Members of Legislative Assembly and Members of Legislative Council shall be listed, in Additional Cause List, without requirement of Urgency Application.
5. Urgency applications shall be placed before the Bench having jurisdiction over the matter, provided urgency applications in TU/PH matters shall be placed before the TU/PH Bench.
6. The Daily Cause List shall not be printed/published till further orders.
7. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
8. The High Court shall function in accordance with the Modalities and Arrangement dated 24.07.2020 for functioning of High Court during COVID-19.
