### **INSTRUCTIONS FOR ELECTRONIC FILING (E-FILING)**

In light of the order dated 26<sup>th</sup> April 2021 of Hon'ble the Acting Chief Justice regarding filing at Allahabad to be permitted only through e-mode until further orders, certain instructions for electronic filing were notified vide a notice dated 26.04.2021.

Further, vide order of Hon'ble the Acting Chief Justice dated 29<sup>th</sup> of April 2021, His Lordship has been pleased to modify the *Notice dated 26.04.2021 regarding Instruction for Electronic Filing (E-Filing)* to the following extent :-

1. The facility of e-filing of petition(s), application(s), counter(s), rejoinder(s), affidavit(s), vakalatnama(s), etc. shall be available through the e-portal available on the official website of the High Court ([www.allahabadhighcourt.in](http://www.allahabadhighcourt.in)).
2. The requirement of digital signature to electronically file a case is dispensed with during surge in COVID-19 pandemic.

However, the person e-filing the petition(s), application(s), counter(s), rejoinder(s), affidavit(s), vakalatnama(s), etc. shall ensure proper bookmarking & hyperlinking of the same so that no inconvenience is caused to Hon'ble Court, while accessing various documents therein.

3. The document(s) which require the signature of the party or the Advocate shall physically be signed, be scanned and appended with other pages of the petition at the time of filing the matter.
4. The electronically filed case should be paginated from the very first page of the case file including the index page.
5. The original(s) of documents be retained. The responsibility for producing the original(s) and proving their genuineness, if required, shall be of the Advocate/Litigant-in-Person/Party that has electronically filed case file.
