- During Summer Vacation, in the absence of the Senior Vacation Judge, the next Senior most Vacation Judge shall exercise jurisdiction as postulated in Chapter V Rule 10 (2) of the Rules of the Court, 1952, at Allahabad.
- In Civil cases and Writ Petitions which require immediate attention, as postulated in 2nd part of sub-Rule (1) of Rule 10 of Chapter V of the Rules of the Court, 1952, a separate paragraph showing the urgency be specifically mentioned in the petition itself.
- Applications regarding urgent hearing of Writ Petitions (excluding Criminal Writs and Habeas Corpus matters, which shall be dealt in Criminal Side) and Cases of Civil nature, during the summer vacation shall be filed before the appropriate Vacation Benches.
- All left out/passed over fresh Criminal Matters, which could not be taken up prior to the Summer Vacation, will be taken up by the appropriate Vacation Benches during summer Vacation provided that Part Heard and Tied Up matters shall be placed before such Benches, if available.
- All such Fresh Criminal Matters (including Criminal Writs and Habeas Corpus matters), which could not be taken up prior to the Summer Vacation, will be taken up by the appropriate Vacation Benches during the summer vacation, Part Heard and Tied Up matters shall be placed before such Benches, if available.
- Mentioning, if any, of Division Bench cases (Civil and Criminal) and Single Bench cases (Civil and Criminal) shall be made before the Senior Vacation Judge.
