**NOTICE**

The High Court Legal Services Sub-Committee, High Court of Judicature at Allahabad, Lucknow is preparing a panel of Advocates in consonance with Rule 8 of National Legal Services Authority (Free and Competent Legal Services Authority) Regulations, 2010.

Applications are, therefore, invited in the given format from Legal Practitioners having experience of three years and more at the Bar for their empanelment as Panel Advocate. The Advocates who are desirous to conduct the cases or proceedings on behalf of the person entitled for legal aid, legal advice or legal services may apply. The Panel Lawyers shall conduct the cases before Hon'ble High Court of Judicature at Allahabad, Lucknow and Central Administrative Tribunal, Board of Revenue at Lucknow and other Authorities constituted under any law, other than District Courts.

Application form along with detailed instructions, terms and conditions of empanelment can be downloaded from Official website of Hon'ble Allahabad High Court ([www.allahabadhighcourt.in](http://www.allahabadhighcourt.in)).

1. The candidate must apply on the format prescribed by the High Court Legal Services Sub-Committee, High Court of Judicature at Allahabad, Lucknow only. No other format will be entertained.
2. The candidates are advised to read the instructions contained in the advertisement carefully to ensure that they are eligible for empanelment in High Court Legal Services Sub-Committee, High Court of Judicature at Allahabad, Lucknow in terms of qualification, and other terms and conditions.
3. The candidate shall enclose self attested photocopy of L.L.B. Degree and Certificate of enrollment issued by State Bar Council under the Advocates Act, 1961 and an experience Certificate issued by the Bar Association along with the application form.
4. Applications shall be accompanied with proof of the professional experience with special reference to the type of cases.
5. Please mention your contact number and email address properly.
6. The last date for submission of complete **Application form is 20.07.2024**. No application would be accepted after last date.
7. The candidate shall affix the latest passport size colored photograph on the application form and sign the same in such a manner that part of signature appears on the form and part on the photograph.
8. The advocates applying for Panel have to submit copies of atleast 02 (two) orders/judgments (passed by Hon'ble High Court of Allahabad) wherein they have argued the case independently.
9. Complete Application Form along with requisite documents shall be submitted in the office of Registrar (J) Stationery/Secretary, High Court Legal Services Sub-Committee, Room No.25, High Court of Judicature at

Allahabad, Lucknow from **04.07.2024 to 20.07.2024 between 11:00 AM to 01:00 PM and 02:00 PM to 04:00 PM on any working day.**

10. The result will be made available on Official website of Hon'ble Allahabad High Court ([www.allahabadhighcourt.in](http://www.allahabadhighcourt.in)) and on the notice board of the High Court of Judicature at Allahabad, Lucknow.

11. The term of new panel shall be for a period of three years, commencing from the date of appointment. Panel Advocates will be paid fees as per approved Schedule of Fees.

12. If work of the panel Advocate is found unsatisfactory or the Advocate is found to be guilty of charging or collecting or demanding any remuneration from an aided person in any form or contravenes the Scheme of the Act, Rules and the Regulations, shall be removed from the panel.

13. Persons facing proceedings or adjudged guilty under the Criminal Law, Contempt of Courts Act or under the Advocates Act shall not be eligible for appointment.

14. If it is found that the candidate does not fulfill any of the eligibility conditions, his or her candidature shall not be considered.

15. The advocates on the existing panel of High Court Legal Services Sub-Committee, High Court of Judicature at Allahabad, Lucknow who wish to continue on the panel, may apply afresh.

16. The work assigned by the Sub-Committee has to be attended on priority basis. No case assigned by the Sub-Committee should go unattended for the reason that the Ld. Advocate is busy in his private matter.
