

ARRANGEMENT

1. The Division Bench presided over by Hon'ble Mr. Justice Anjani Kumar Mishra (Court No.3) in addition to its own determination, will take up the fresh cases from serial nos.1 to 50 of Court No.40 (The Division Bench presided over by Hon'ble Mr. Justice Shekhar B. Saraf).
2. The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi (Court No.29) in addition to its own determination, will take up the fresh cases from serial nos.51 to 100 of Court No.40 (The Division Bench presided over by Hon'ble Mr. Justice Shekhar B. Saraf).
3. In modification of earlier order dated 16.08.2024, the Division Bench presided over by Hon'ble Mr. Justice V. K. Birla (Court No.42) in addition to its own remaining determination, will take up the the fresh cases from serial nos.184 to 213 and the fresh cases from serial nos.214 to 243 of Court No.42, which were earlier transferred to Court Nos.46 and 45 respectively.
4. In modification of earlier order dated 16.08.2024, the Division Bench presided over by Hon'ble Mr. Justice S. D. Singh (Court No.39) in addition to its own determination, will take up the determination (except the fresh cases from serial nos.1 to 100) of Court No.40 (The Division Bench presided over by Hon'ble Mr. Justice Shekhar B. Saraf).

In modification of earlier order dated 16.08.2024, the Division Bench presided over by Hon'ble Mr. Justice Arvind Singh Sangwan (Court No.46) in addition to its own determination, will take up the determination of Court No.45 (The Division Bench presided over by Hon'ble Mr. Justice Siddhartha Varma).

In modification of earlier order dated 16.08.2024, Hon'ble Mr. Justice Manoj Bajaj (Court No.81) in addition to his own remaining determination, will take up the fresh cases from serial nos.670 to 699 of Court No.81, which were earlier transferred to Court No.91 (Hon'ble Mr. Justice Ram Manohar Narayan Mishra).
7. In modification of earlier order dated 17.08.2024, Hon'ble Mr. Justice Ram Manohar Narayan Mishra will sit singly in Court No.82 and will take up the determination of Court No.82 (Hon'ble Mr. Justice Subhash Chandra Sharma) and will also take up the determination of Court No.75 (Hon'ble Mrs. Justice Manju Rani Chauhan).
8. Hon'ble Mr. Justice Manjive Shukla will sit singly in Court No.40 and will take up the fresh cases from serial nos.314 to 413 of Court No.32 (Hon'ble Dr. Justice Y. K. Srivastava).
