7. Hon'ble Mr. Justice Piyush Agrawal (Court No.2) in addition to his own determination, will take up the determination of Court No.35 (Hon'ble Mr. Justice Vipin Chandra Dixit).
8. Hon'ble Mrs. Justice Manju Rani Chauhan (Court No.75) in addition to her own determination, will take up the determination of Court No.82 (Hon'ble Mr. Justice Subhash Chandra Sharma).
9. In modification of earlier order dated 13.09.2024, Hon'ble Dr. Justice Y. K.
