8. Hon'ble Mr. Justice Rohit Ranjan Agarwal (Court No.9) in addition to his own determination, will take up the determination of Court No.4 (Hon'ble Mr. Justice Ajit Kumar), on 13.12.2024.
9. Hon'ble Mr. Justice Syed Qamar Hasan Rizvi will sit singly in Court No.51 at 2 P.M. till the formation of regular Division Bench work in Court No.45 and will take up the fresh cases from serial nos.126 to 155 of Court No.34 (Hon'ble Mr. Justice Manish Kumar Nigam), on 13.12.2024.
