<u>Documents required with application</u>: All the applicants shall submit their applications containing self-attested xerox copies of the documents of the particulars mentioned in the application alongwith the photocopies of character roll entries of the last 5 years of their Government Job.

<u>Submission of Form:</u> All the applicants shall submit their applications along with all the relevant documents to the District Court(s) of the district(s) for which they are applying for the post of SJM. The District Judge(s) after proper scrutiny shall only forward those applications to the High Court which he finds fit for the post of SJM alongwith his remarks without any delay.
