

Due to completion of 70 years' of age of **Sri Ashok Kumar Srivastava, SJM, Barabanki** on 01.01.2025, the post of Special Judicial Magistrate is going to fall vacant in your judgeship.

Therefore, this Hon'ble Court has desired that fresh applications be invited for consideration of appointment on the aforesaid upcoming vacancy.

Therefore, you are requested to recommend/forward the names of only such eligible persons aspiring to be Special Judicial Magistrate, who qualify as per definition mentioned in Section 11 of the BNSS (*who holds or has held any post under the government and possesses the degree of law or otherwise is well experienced in relation to the legal affairs*).

Kindly recommend/ forward the names of eligible applicants for appointment on the said post, duly filled up on the prescribed proforma (copy enclosed), along with their self-attested certificates and character roll entries of last five years. Certificates and character roll entries will not be required for ex-SJMs appointed by the State of U.P.; However best four judgments of ex-SJMs will be required. After proper scrutiny, **only forward those applications to the High Court that you find suitable for the post of Special Judicial Magistrate along with your remarks, without delay.** The last date for accepting applications for the post of Special Judicial Magistrate is 16.02.2025.

I am, further, to request you to make advertisement in the shape of news item in the National as well as Regional Newspapers to the effect that the eligible persons may apply for the appointment to the post of Special Judicial Magistrate for which the details may be seen on the official website of this Hon'ble Court.

**(B) Qualification:** A person shall not be qualified for appointment as a Special Judicial Magistrate unless he-

- (a) holds or has held any post under the Government.
- (b) Possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court.

**(C) Term of Office:** The term of the office as Special Judicial Magistrate shall be four years or till attaining the age of 70 years, whichever is earlier.

**(D) Instruction:** All the applicants shall submit their applications (on proforma annexed herewith) containing self-attested xerox copies of the documents as mentioned in the application along with the photocopies of character roll entries of last 5 years to the District Judge concerned, who shall after making proper scrutiny forward the same to the Hon'ble Court alongwith his remarks without any delay for consideration of the Hon'ble Court.

Qualification: A person shall not be qualified for appointment as a Special Judicial Magistrate unless he/she:-

- (a) holds or has held any post under the Government; and
- (b) possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court.

Term of Office: The term of the office as Special Judicial Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

Documents required with application: All the applicants shall submit their applications containing self-attested xerox copies of the documents of the particulars mentioned in the application alongwith the photocopies of character roll entries of the last 5 years of their Government Job.

Submission of Form: All the applicants shall submit their applications along with all the relevant documents to the District Court(s) of the district(s) for which they are applying for the post of SJM. The District Judge(s) after proper scrutiny shall only forward those applications to the High Court which he finds fit for the post of SJM alongwith his remarks without any delay.
