Terms and Conditions

1. The Registrar General on behalf of High Court Allahabad invites the sealed bid from the interested firms for sale of old computer equipments, printers, UPS, etc. kept at Computer Centre, High Court, Allahabad and Lucknow Bench.
2. Sealed Bids once submitted cannot be withdrawn.
3. Bidders are required to submit bids for all the items mentioned in **Table-[A] & Table-[B]**. Bids submitted for part of the items mentioned in **Table-[A] & Table-[B]** shall not be considered.
4. The interested firms may submit their sealed bids in attached proforma along with **Earnest Money Deposit (E.M.D.) of Rs.20,000/-** through Demand Draft in favour of Registrar General, High Court, Allahabad. Any bid not accompanied by an acceptable Earnest Money, shall be rejected.
5. Sealed Bids addressed to Registrar General, High Court, Allahabad in attached proforma (Annexures A, B and C) must reach **Joint Registrar(J)(Computer), Computer Centre, C.I.T. Building, High Court, Allahabad** latest by **4.00 p.m. 22 March, 2025**. Any bid received after this deadline prescribed will be returned unopened to the firm.
6. Quantity/items fixed for selling as mentioned in **Table-[A] & Table-[B]** may change as per discretion of Hon'ble High Court.
7. Before the deadline for submission of bid, the High Court may modify the auction documents by issuing addenda. Any addendum thus issued shall be part of the auction documents and same shall be published in the official website of the Court.
8. Each page of the auction document shall be typed or written in indelible ink and shall be signed by the representative duly authorized to sign on behalf of the firm.
9. The tender shall contain no overwriting, alterations or additions, except those to comply with instructions issued by the High Court.
10. The Earnest Money of unsuccessful bidders will be returned at the earliest after the finalization of auction process.
11. The Earnest Money of the successful firm will be either adjusted against the overall bid amount or returned after firm deposits the full amount.
12. The bids received will be opened in the presence of the firms/representatives who choose to attend at the time, date and place specified in the auction document.
13. The High Court will award the Contract to the firm whose bid has been determined to be substantially responsive to the auction documents and who has offered the highest price for the purchase of items.
14. Notwithstanding the above Clause, the High Court reserves the right to accept or reject any bid, to extend the date of submission & opening if sufficient number of bids are not received, to cancel the tender process or to reject all tenders.
15. The firm whose bid has been accepted will be informed by letter. The bidder has to deposit this requisite amount within the period of 7 days after the receipt of letter of acceptance thereafter firm will be allowed to take away the items deemed sold.
16. Short-listed successful bidder shall deposit requisite amount within 7 days from the date of receipt of acceptance letter failing which the High court shall cancel the bid and forfeit the Earnest Money deposited.
17. All applicable taxes, if any at admissible rate, have to be paid by the successful bidder.
