Hon'ble Supreme Court Committee on Road Safety, in its meeting dated 05.02.2025 has resolved to issue the following directions regarding road safety measures, specifically helmet and seat belt usage:

1. All officers and employees of Government and Semi-Government offices in Uttar Pradesh who come to office on two-wheelers should compulsorily wear helmets and the pillion rider should also wear helmet.
2. Similarly, officers/ employees who come to office in four-wheelers should not use mobile phones while driving and the driver along with all co-passengers should wear seat-belts.
3. All the heads of departments and heads of offices should ensure that their subordinate officers and employees should follow these instructions completely.
4. Security personnel should check helmet and seat belt compliance at the entrance of all government and semi-government offices. Entry without helmet/ seat belt should be prohibited.
5. The traffic police and district administration should ensure strict compliance of this rule and take necessary action against violators.
6. All employees should be aware of the importance of promoting road safety and make the use of helmets and seat belts a mandatory part of their daily routine.
7. Action as per rules may be considered against the officers/ employees who violate the rules.
8. The above instructions are not just a formality but are extremely necessary to ensure the safety of every officer and employee. We all should take this initiative seriously and create a positive environment in the society.


All the Officers/ Officials/ Staff of High Court, Allahabad and its Bench at Lucknow are hereby directed to strictly comply with the aforementioned directives regarding road safety measures while commuting to and from work.
