The Division Bench comprising Hon'ble Mr. Justice Siddharth and Hon'ble Mr. Justice Zafeer Ahmad will sit in Court No.47 to take up the determination to be taken up there and will also take up the fresh cases from serial nos.182 to 241 of Court No.43 (The Division Bench presided over by Hon'ble Mr. Justice Siddhartha Varma). Thereafter, Hon'ble Mr. Justice Siddharth will sit singly in Court No.47 and in addition to his own Single Bench determination at 2.00 P.M., will take up the fresh cases from serial nos.41 to 90 of Court No.66 (Hon'ble Mr. Justice Ashutosh Srivastava).
- **6.** Hon'ble Mr. Justice Chandra Kumar Rai (Court No.37) in addition to his own determination, will take up the determination of Court No.49 (Hon'ble Mr. Justice J. J. Munir).
