ENGAGEMENT LETTER

No. 3632 / Establishment : Dated : Allahabad : August 30, 2025.

With reference to his/her application in response to **Advertisement No. 01/Research Associates/2025** for being considered for the post of Research Associate in the High Court of Judicature at Allahabad, he/she is hereby informed that he/she has been selected as a Research Associate to be attached with Hon'ble Judges for a period of one year on a fixed honorarium of **Rs. 40,000/-** per month with no other allowances and without any other perquisite such as residential accommodation etc. The engagement shall be purely contractual for a fixed term of one year, which may be extended by one year, subject to satisfactory performance. The maximum term will not exceed two years. However, the engagement may be terminated at any time, without prior notice.

It is made clear to him/her that the above short term engagement shall not confer upon him/her any right to claim regular appointment like other appointees in the Registry. The said engagement shall be subject to the following conditions :-

1. For two years, from the date of termination of engagement, he/she shall not appear in any case before the Hon'ble Judge to whom he/she had been attached, irrespective whether he/she had or had not worked on that case during the period of his/her engagement as Research Associate. He/she shall have to furnish an undertaking to the above effect.
2. He/She shall be governed by such rules of attendance, leave and other related matters as might be prescribed from time to time by Hon'ble the Chief Justice of High Court of Judicature at Allahabad.
3. After three months from the date of joining, performance and work done by the Research Associate will be reviewed by Hon'ble Judge with whom he/she is attached/ Ld. Registrar General and if the performance/work is not found satisfactory, the engagement will be cancelled.

If he/she is willing to accept the above terms and conditions to be engaged as a Research Associate, he/she may report to the undersigned **from 01.09.2025 to 09.09.2025.**
