Instructions / Terms & Conditions

1. The Registrar General on behalf of High Court Allahabad invites the sealed quotations from the interested firms for supply of 432 nos. (328 for Allahabad + 104 for Lucknow) single-user licenses of antivirus software, preferably provided as a bundled package, for installation on standalone systems running on Windows operating systems, with a subscription period of 1 year.
2. Quotation once submitted cannot be withdrawn. Any quotation received by the office of the Registrar General after the deadline prescribed in Notice will be returned unopened to the firm. Quotation must be submitted in a sealed envelope clearly super-scribed with "Quotation for Antivirus Software".
3. Quoted rates should be valid for 120 days from the date of opening of quotations.
4. Each page of the quotation (Terms & Conditions, General Information & Financial Information) shall be typed or written in indelible ink and shall be signed and stamped by the representative duly authorized to sign on behalf of the firm / Company. The quotation shall contain no overwriting, alterations or additions, except those to comply with instructions issued by the High Court.
5. All reputed, authorized vendors/ suppliers/ firms must quote price (inclusive all taxes viz. GST etc.).
6. Evaluation Method – Total value wise evaluation.
7. The antivirus software quoted must strictly adhere to all the Technical Specifications mentioned at Table-'A'. **A signed undertaking confirming full compliance with the Technical Specification must be submitted along with the quotation.** In the event that the supplied product is found to be non-compliant with any of the specified technical criteria at any stage whether during evaluation, delivery, or post-installation, it shall be immediately rejected, and appropriate legal action may be initiated against the concerned firm/vendor. Furthermore, if any payment is pending at the time such non-compliance is identified, the same shall be withheld and deemed forfeited without any obligation on the part of the High Court.
8. The tenderer / bidder / firm may be asked to provide a demonstration of all the features related to quoted Anti-Virus Software at the High Court, Allahabad. The schedule and other relevant details for the demonstration shall be communicated in due course. Failure to provide the required demonstration, if asked, at the specified location and time shall result in outright rejection of the bidder's quotation, without any further correspondence. Any expenses for demonstration of quoted Anti-Virus Software will not be borne by the Buyer.
9. The High Court will award order for supply of Antivirus software to the firm whose quotation has been determined to be substantially responsive and who has offered the lowest price for supply of Antivirus software subject to compliance of all the Technical Specification as mentioned at Table-'A'.
10. Notwithstanding the above clause, the High Court reserves the right to accept or reject any quotation, to extend the date of submission & opening if sufficient number of quotations are not received. High Court reserves the rights to terminate the quotation without assigning any reason thereof at any stage.

- 12.All applicable taxes, if any at admissible rate, has to be paid by the successful firm.
- 13.The Antivirus software must be delivered within 15 days from the date of issuance of the Purchase Order.
- 14.Payment will be made after successful supply, testing and installation of Antivirus Software.
- 15.The High Court (Buyer) reserves the right to increase or decrease the quantity of Antivirus Software at the time of issuance of Purchase Order.
- 16.The High Court (Buyer) reserves the right to purchase an additional quantity of Antivirus Software by issuing a single/multiple Repeat Purchase Order(s) to the seller for the supply of the Antivirus Software under same rates, terms, and conditions. This option may be exercised at any time within a period of one year from the date of issuance of Purchase Order.
