

ORDER No.1 / Dt. 12.11.2025

9. Hon'ble Mrs. Justice Garima Prashad will sit singly in Court No.33 after Regular Division Bench work and will take up the Daily Cause List cases from serial nos.275 to 304 of Court No. 52 (Hon'ble Mrs. Justice Manju Rani Chauhan), on 13.11.2025.
