

ORDER No.1 / Dt. 24.11.2025

1. The Division Bench comprising Hon'ble Mr. Justice J. J. Munir and Hon'ble Mr. Justice Tarun Saxena will sit in Court No.44 to take up the determination to be taken up there and will also take up the fresh cases from serial nos.1 to 5 and the Daily Cause List cases from serial nos.6 to 105 of Court No.43 (The Division Bench presided over by Hon'ble Mr. Justice Salil Kumar Rai).
2. In modification of earlier order dated 22.11.2025, the Division Bench comprising Hon'ble Mr. Justice Siddharth and Hon'ble Mr. Justice Vinai Kumar Dwivedi will sit in Court No.46 to take up the determination to be taken up there.
3. The Division Bench presided over by Hon'ble Mr. Justice Ajit Kumar (Court No.4) in addition to its own determination, will take up the determination of Court No.29 (The Division Bench presided over by Hon'ble Mr. Justice M. C. Tripathi).

The Division Bench presided over by Hon'ble Mr. Justice Rajeev Misra (Court No.47) in addition to its own determination, will take up the determination (except the fresh cases from serial nos.1 to 5 and the Daily Cause List cases from serial nos.6 to 105) of Court No.43 (The Division Bench presided over by Hon'ble Mr. Justice Salil Kumar Rai).
5. Hon'ble Mr. Justice Krishan Pahal (Court No.67) in addition to his own determination, will take up the determination of Court No.69 (Hon'ble Mr. Justice Arun Kumar Singh Deshwal).
6. Hon'ble Mr. Justice Jitendra Kumar Sinha (Court No.72) in addition to his own determination, will take up the determination of Court No.70 (Hon'ble Mr. Justice Santosh Rai).
7. Hon'ble Mr. Justice Kunal Ravi Singh will sit singly in Court No.7 and will take up the fresh cases from serial nos.105 to 154 and the Daily Cause List cases from serial nos.276 to 375 of Court No.6 (Hon'ble Dr. Justice Y. K. Srivastava).
8. Hon'ble Dr. Justice Ajay Kumar -II will sit singly in Court No.69 at 2.00 P.M. till the formation of Regular Division Bench in Court No.47 and will take up the Daily Cause List cases from serial nos.329 to 358 of Court No.91 (Hon'ble Mr. Justice Abdul Shahid).
9. In modification of earlier order dated 22.11.2025, Hon'ble Mr. Justice Divesh Chandra Samant will sit singly in Court No.19 and will take up the determination of Court No.19 (Hon'ble Mr. Justice Divesh Chandra Samant), which was earlier transferred to Court No.92 (Hon'ble Mr. Justice Chawan Prakash).
