

## **ORDER No.2 / Dt. 08.01.2026**

- 1. On account of Full Court Farewell Reference at 10.00 A.M. of Hon'ble Mr. Justice M. K. Gupta on his elevation as The Chief Justice of Uttarakhand High Court, the Courts will sit at 11.15 A.M. on 09.01.2026.**
