

## **ORDER No.1 / Dt. 16.01.2026**

1. In modification of earlier order dated 14.01.2026, the Division Bench comprising Hon'ble Mr. Justice Rajiv Gupta and Hon'ble Mr. Justice Tarun Saxena will sit in Court No.45 to take up the remaining determination to be taken up there and will also take up the the fresh cases from serial nos.163 to 242, which were earlier assigned to Court No.49 (he Division Bench presided over by Hon'ble Mr. Justice Ajay Bhanot).
2. The Division Bench presided over by Hon'ble Mr. Justice Siddharth (Court No.46) in addition to its own determination, will take up the fresh cases from serial nos.1 to 14 and the Daily Cause List cases from serial nos.15 to 114 of Court No.49 (The Division Bench presided over by Hon'ble Mr. Justice Ajay Bhanot).
3. The Division Bench presided over by Hon'ble Mr. Justice Chandra Dhari Singh (Court No.48) in addition to its own determination, will take up the determination (except the fresh cases from serial nos.1 to 14 and the Daily Cause List cases from serial nos.15 to 114) of Court No.49 (The Division Bench presided over by Hon'ble Mr. Justice Ajay Bhanot).
4. In modification of earlier order dated 14.01.2026, Hon'ble Mr. Justice Shekhar Kumar Yadav (Court No.50) in addition to his own determination, will take up the determination of Court No.83 (Hon'ble Mr. Justice Subhash Chandra Sharma), which was earlier transferred to Court No.90 (Hon'ble Mr. Justice Manoj Bajaj).
5. Hon'ble Mr. Justice Kshitij Shailendra will sit singly in Court No.90 at 2.00 P.M. and will take up the fresh cases from serial nos.367 to 396 of Court No.81 (Hon'ble Mr. Justice Vivek Kumar Singh).
6. In modification of earlier order dated 14.01.2026, Hon'ble Mr. Justice Tarun Saxena will sit singly in Court No.89 at 3.00 P.M. till the formation of Division Bench in Court No.45 and will take up the fresh cases from serial nos.307 to 336 of Court No.85 (Hon'ble Mr. Justice Madan Pal Singh).
7. Hon'ble Mr. Justice Jai Prakash Tiwari (Court No.92) in addition to his own determination, will take up the determination (except the fresh cases from serial nos.323 to 352) of Court No.88 (Hon'ble Mr. Justice Vinod Diwakar).
8. Hon'ble Mrs. Justice Vani Ranjan Agrawal (Court No.93) in addition to her own determination, will take up the determination of Court No.90 (Hon'ble Mr. Justice Manoj Bajaj).
