





The Search Committee, Manipur Lokayukta invites fresh applications for filling up 1 (one) post of Chairperson and 2 (two) posts of Members in the Manipur Lokayukta. Out of these 2 (two) posts of members, one shall be Judicial Member. The qualifications are laid down in the Manipur Lokayukta Act, 2014 as provided below.

For Chairperson:-

A person who is or has been a Chief Justice of a High Court or a Judge of a High Court or an eminent person who fulfills the eligibility specified in clause (b) of sub-section(3) of the Manipur Lokayukta Act, 2014, which is a person of impeccable integrity and outstanding ability having special knowledge and expertise of not less than 25 (twenty five) years in matters relating to anti-corruption policy, public administration, vigilance, finance including insurance and banking, law and management and not less than 50 (fifty) years of age.

For Judicial member:-

A person who is or has been a Judge of a High Court.

For Member other than a Judicial member:-

A person of impeccable integrity and outstanding ability having special knowledge and expertise of not less than 25 (twenty-five) years in the matters relating to anti-corruption policy, public administration, vigilance, finance including insurance and banking, law and management and not less than 50 (fifty) years of age.

The Chairperson or a Member shall not:-


- (i). Be a member of Parliament or a member of the Legislature of any State or Union territory;
- (ii). Be a person convicted of any offence involving moral turpitude;
- (iii). Be a member of the Panchayat or Municipality or District Council;
- (iv). Be a person who has been removed or dismissed from the service of the Union or a State,
- (v). hold any office of trust or profit (*other than his office as the Chairperson or a Member*) or be affiliated with any political party or carry on any business or practice any profession and, accordingly, before he enters upon his office, a person appointed as a Chairperson or a Member, as the case may be, shall, if :-
  - a) he holds any office of trust or profit, resign from such office, or
  - b) he is carrying on any business, sever his connection with the conduct and management of such business; or
  - c) he is practising any profession, cease to practise such profession.

How to apply:

The vacancies have been circulated to the Registrar of High Courts, Chief Secretaries of State Governments and Secretaries in the Departments of the State Government of Manipur, calling for nomination of eligible candidates.
