

## **ORDER No.1 / Dt. 02.02.2026**

8. Hon'ble Mr. Justice Praveen Kumar Giri (Court No.77) in addition to his own determination, will take up the fresh cases from serial nos.251 to 500 and the Daily Cause List cases from serial nos.754 to 853 of Court No.74 (Hon'ble Mr. Justice Sanjay Kumar Pachori).

In modification of earlier order dated 31.01.2026, Hon'ble Mr. Justice Santosh Rai (Court No.70) in addition to his own determination, will take up the fresh cases from serial nos.1 to 150 and the Daily Cause List cases from serial nos.274 to 373 of Court No.65 (Hon'ble Dr. Justice Gautam Chowdhary), which were earlier transferred to Court No.66 (Hon'ble Mr. Justice Krishan Pahal). ,
10. Hon'ble Mr. Justice Rajiv Lochan Shukla (Court No.80) in addition to his own determination, will take up the determination (except the fresh cases from serial nos.1 to 500 and the Daily Cause List cases from serial nos.754 to 853) of Court No.74 (Hon'ble Mr. Justice Sanjay Kumar Pachori).
