

ORDER No.2 / Dt. 11.02.2026

9. Hon'ble Mr. Justice Harvir Singh (Court No.86) in addition to his own determination, will take up the determination of Court No.89 (Hon'ble Mr. Justice Divesh Chandra Samant), on 12.02.2026.
