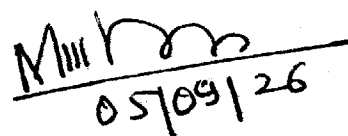

ENGAGEMENT LETTER

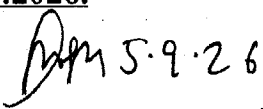

With reference to his application in response to **Advertisement No. 01/Research Associates/2026** for being considered for the post of Research Associate in the High Court of Judicature at Allahabad, he is hereby informed that he has been selected as a Research Associate to be attached with Hon'ble Judges for a period of one year on a fixed honorarium of **Rs. 40,000/-** per month with no other allowances and without any other perquisite such as residential accommodation etc. The engagement shall be purely contractual for a fixed term of one year, which may be extended by two more years, subject to satisfactory performance. The maximum term will not exceed three years. However, the engagement may be terminated at any time, without prior notice.

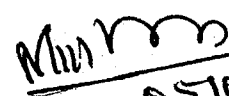
It is made clear to him that the above short term engagement shall not confer upon him any right to claim regular appointment like other appointees in the Registry. The said engagement shall be subject to the following conditions :-

1. For two years, from the date of termination of engagement, he shall not appear in any case before the Hon'ble Judge to whom he had been attached, irrespective whether he had or had not worked on that case during the period of his engagement as Research Associate. He shall have to furnish an undertaking to the above effect.
2. The period worked as Research Associate shall be treated solely and exclusively as a period of engagement/work. Such period shall neither be counted as a "Pre-Appointment Training Period" in any manner whatsoever, nor shall it be reckoned towards any "Post-Appointment Service Benefits." Accordingly, this period shall not be counted for any service-related or retirement benefits in any subsequent appointment/service tenure.
3. He shall be governed by such rules of attendance, leave and other related matters as might be prescribed from time to time by Hon'ble the Chief Justice of High Court of Judicature at Allahabad.
4. After three months from the date of joining, performance and work done by the Research Associate will be reviewed by Hon'ble Judge with whom he is attached/ Ld. Registrar General and if the performance/work is not found satisfactory, the engagement will be cancelled.

If he is willing to accept the above terms and conditions to be engaged as a Research Associate, he may report to the undersigned **from 07.09.2026 to 11.09.2026.**
