

ORDER No.1/ Dt. 07.09.2026

- 1. On account of Full Court farewell Reference at 10.00 A.M. of Hon'ble Mr. Justice M. C. Tripathi on his elevation as The Chief Justice of High Court of Bombay, the Courts will sit at 11.30 A.M.**
- 2. In modification of earlier order dated 05.09.2026, The Division Bench presided over by Hon'ble Mr. Justice Siddhartha Varma (Court No.44) in addition to its own determination, will take up the fresh cases from serial nos.154 to 253 of Court No.47 (The Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta) and will also take up the determination of Court No.46 (The Division Bench presided over by Hon'ble Mr. Justice Rajeev Misra).**
- 3. The Division Bench presided over by Hon'ble Mr. Justice S. D. Singh (Court No.39) in addition to its own determination, will take up the fresh cases from serial nos.1 to 50 and the Daily Cause List cases from serial nos.101 to 200 of Court No.1 (The Division Bench presided over by Hon'ble Mr. Justice Ajit Kumar).**
- 4. In modification of earlier order dated 05.09.2026, the Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta (Court No.47) in addition to its own remaining determination, will take up the fresh cases from serial nos.354 to 453 and 554 to 653 of Court No.47, which were earlier transferred to Court No.46 and assigned to Court No.49 respectively.**
- 5. The Division Bench presided over by Hon'ble Mr. Justice Chandra Dhari Singh (Court No.48) in addition to its own determination, is assigned the fresh cases from serial nos.454 to 553 of Court No.47 (The Division Bench presided over by Hon'ble Mr. Justice Rajiv Gupta) and will also take up the determination of Court No.49 ((The Division Bench presided over by Hon'ble Mr. Justice Ajay Bhanot).**
- 6. The Division Bench presided over by Hon'ble Mr. Justice Prakash Padia (Court No.5) in addition to its own determination, will take up the determination (except the fresh cases from serial nos.1 to 50 and the Daily Cause List cases from serial nos.101 to 200) of Court No.1 (The Division Bench presided over by Hon'ble Mr. Justice Ajit Kumar).**
- 7. Hon'ble Dr. Justice Y. K. Srivastava (Court No.35) in addition to his own determination, will take up the fresh cases from serial nos.1 to 20 and the Daily Cause List cases from serial nos.38 to 137 of Court No.7 (Hon'ble Mr. Justice Piyush Agrawal).**
- 8. Hon'ble Mr. Justice Dinesh Pathak (Court No.32) in addition to his own determination, will take up the determination (except the fresh cases from serial nos.1 to 20 and the Daily Cause List cases from serial nos.38 to 137) of Court No.7 (Hon'ble Mr. Justice Piyush Agrawal).**
- 9. Hon'ble Mrs. Justice Garima Prashad will sit singly in Court No.1 and will take up the fresh cases from serial nos.125 to 224 of Court No.37 (Hon'ble Mr. Justice Chandra Kumar Rai).**
- 10. Hon'ble Dr. Justice Ajay Kumar-II will sit singly in Court No.91 and will take up the determination of Court No.91 (Hon'ble Mr. Justice Tej Pratap Tiwari).**
- 11. Hon'ble Mr. Justice Divesh Chandra Samant will sit singly in Court No.78 and will take up the determination of Court No.78 (Hon'ble Mr. Justice Subhash Chandra Sharma).**
