The result of the Judicial Officers/candidates who have been declared successful in UPHJS Direct Recruitment Main Written Examination, 2018(Part-II) and have filed various writ petitions in the Hon'ble Supreme Court/Hon'ble High Court shall be subject to the final outcome of the pending writ petitions. They are permitted to appear in the interview provisionally and if it is found that any Judicial Officer/petitioners who is declared successful in written examination and have not filed writ petitions in the Hon'ble Court(s), their candidature shall be rejected.
