Note:

1. In view of pandemic of COVID-19, the roster w.e.f. 13.07.2020 shall remain inoperative till further orders.

4. The Daily Cause List shall not be printed/published till further orders.
5. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
6. Hearing through physical appearance of Ld. Counsels before Hon'ble Courts shall continue as per prevailing practice. **However**, cases shown for hearing through video conferencing in published list shall be taken up before Hon'ble Chief Justice's Court and Hon'ble Courts in Court Room Nos. 1 to 49 in pre lunch session and in Court Room Nos. 50 to 93 in post lunch session.
