2. Experience Certificate as mentioned in your application form.
3. Domicile Certificate (only for reserved category candidates of U.P.)
4. Caste Certificate (only for reserved category candidates of U.P.)
5. Certificate in favour of Sports Person. (in case of claiming reservation under Sportsmen category)
6. No Objection Certificate & relieving letter (only for Central/State Government/ P.S.U. Employee).
7. Discharge Certificate (only for Ex- servicemen of Navy/Naval Academy, Army and Air Force service) . The Ex-Servicemen (E.S.M.) candidate will also have to give

undertaking on affidavit on Stamp Paper of Rs. 10/-, addressed to the Registrar General, High Court, Allahabad, to the effect that you have not availed the benefits of reservation provided under Ex-Servicemen (E.S.M.) category for any post established and run by the Central/State Government.

**8.** Disability certificate in favour of Disabled person.

**9.** Identity Card issued by competent authority.

**10** Two Character Certificates from the Members of Parliament or State Legislature or Gazetted Officer to the effect that you bear a good moral character and have never taken part in any act subversive of law and order.

**11.** A Medical Certificate from the Chief Medical Officer of their district to the effect that you are in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of their official duties as a Sweeper/Cook/ Mali/ Farrash.

**12.** A declaration addressed to the Registrar General, High Court, Allahabad on affidavit on Stamp Paper of Rs. 10/- also be furnished to the effect that you are neither a previous convict nor any criminal case is pending before any Court of Law nor any F.I.R. has been lodged against you.

**13.** Two set of attested/ self attested copies of the mark sheets/certificates/testimonials/Experience certificate and online application form alongwith one passport size coloured photograph, same as uploaded while filling up the online application form.
