Note:-

1. **There shall be no sitting of Courts at High Court, Lucknow Bench, Lucknow on 09th of October, 2020. The cases date fixed for 09th of October, 2020 shall be taken up on 12th of October, 2020.**
2. In view of pandemic of COVID-19, **the roster w.e.f. 13-07-2020 shall remain inoperative** till further orders.
3. Only those **LISTED** matters (except Criminal Cases pertaining to Members of Parliament, Members of Legislative Assembly and Members of Legislative Council) shall be listed in Courts, for which urgency applications, filed through e-mode are allowed by the Court. Such matters shall be listed only in Additional Cause-List.
4. Listed Criminal Cases pertaining to Members of Parliament, Members of Legislative Assembly and Members of Legislative Council shall be listed, in Additional Cause-List, without requirement of Urgency Application.
5. The Daily Cause-List shall not be printed/published till further orders.
6. The administrative order dated 16-12-2013 regarding part-heard and tied-up cases will continue in operation.
7. The administrative order dated 15-11-2018 and 20-06-2019 regarding nominated matters will continue in operation.
8. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
