Age relaxation to Ex-Servicemen as defined under G.O. No.17/2/1981-Karmik-2 dated 28.02.1985 shall be admissible.

Relaxation in upper age limit shall be as per Government Order issued from time to time and as per order passed by Hon'ble the Chief Justice.
