


## प्रेस विज्ञप्ति

**Qualification:** A person **shall not be qualified** for appointment as a Special Judicial Magistrate unless he-

(a) holds or has held any post under the Government;

And

(b) Possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court.

**Term of Office:** The term of the office as Special Judicial Magistrate /Special Metropolitan Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

**Documents required with application:** All the applicants shall submit their applications containing self-attested xerox copies of the documents of the particulars mentioned in the application along with the photocopies of character roll entries of last 5 years.
