4. Candidates are advised to note the following:

- The Admit Card is issued provisionally to the candidates, subject to the fulfillment of the eligibility conditions.
- Issuance of this Admit card, however, shall not necessarily mean acceptance of the fulfillment of eligibility by the candidate, which shall be further scrutinized at the subsequent stages of the recruitment process. Mere possession of this Admit Card shall not entitle the candidate to make any claim to the post.
- Candidate must not mutilate the Admit card or change any entry made therein. Any tampering in the particulars, photograph, signature, thumb impression in this Admit Card shall be considered as Unfair Means (UFM) practice and shall be dealt with as per Law.
- Candidates are advised to preserve a copy of their Admit card in good condition for future reference.
- Admit Card will not be sent by post.

5. In Stage-II examination(s) for Additional Private Secretary (English) & Additional Private Secretary (Hindi), the Candidates will be required to take down the dictation in Shorthand on the copy provided to them and thereafter to transcribe the same on computer within 30 minutes.
