### **NOTICE FOR INVITING APPLICATIONS FOR SELECTION TO THE POST OF CHAIRMAN OF UTTAR PRADESH ELECTRICITY REGULATORY COMMISSION.**

Uttar Pradesh Electricity Regulatory Commission (UPERC) is an autonomous body corporate set up by Government of U.P under the provisions of Regulatory Commission Act, 1998 and continued under section 82 of Electricity Act 2003. UPERC consists of three members including the Chairman of the Commission. The Commission is located at Lucknow, Uttar Pradesh. The Commission has the exclusive power to make regulations for the conduct of its proceedings and discharge of its functions. The Commission is vested with the same powers as that of a Civil Court under the Code of Civil Procedure 1908 (Central Act 5 of 1908) for obtaining information and evidence.

Applications are invited for selection of a suitable person for appointment to the post of Chairman of UPERC which shall fall vacant on 01-07-2023. The qualifications for appointment of Chairman of UPERC, their terms of office and conditions of service are as follows:

#### **Qualifications:**

As provided in section 84(1) of the Electricity Act, 2003, the Chairman of the State Commission shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in, dealing with problem relating to engineering, finance, commerce, economics, law or management.

#### **Terms of office & Conditions of service of Chairman:**

1. The tenure of Chairman of the Commission shall be for a period of 5 years or till she / he attains the age of 65 years, whichever is earlier.
2. If selected, the selected candidate if holding any office under the State Government or Central Government or in any public sector corporation or Government body shall resign or seek voluntary retirement from the service.
3. The Chairman shall not seek reappointment in the service of the State Government, the Central Government, any public sector corporation or Government body at any time after he/she ceases to be Chairman of the Commission.
4. The Chairman shall not accept any employment in any capacity in any organization which has been a party to the proceedings before the Appropriate Commission or employment in any capacity under, or agency of, a person engaged in trading, commercial, industrial or financial business in electricity industry and includes a director of a company or partner of a firm or setting up practice either independently or as partner of a firm or as an advisor or a consultant, for a period of two years from the date he /she ceases to hold post in the UPERC.
5. After ceasing to hold office the Chairman shall not represent any person before the Central Commission or any State Commission in any manner.
6. The Chairman may-
  - (a) relinquish his office by giving in writing to the State Government a notice of not less than three months; or
  - (b) be removed from his office in accordance with the provisions of section 90 of Electricity Act 2003.

7. The Salary of the Chairman shall be the same as that of an Election Commissioner of India. The Chairman shall be entitled to Dearness Allowance and City Compensatory allowance same as the Election Commissioner of India.

**Interested candidates may send their applications with details as below:**

A) Bio - data containing the following details:

- a) Name
- b) Age and Date of Birth
- c) Position now held
- d) Educational Qualifications
- e) Details of posts previously held and experience in any of the field of engineering, finance, commerce, economics, law or management.

B) Details of any office, employment or consultancy agreement or arrangement which she / he has in her / his own name or in any firm , association or persons or body corporate, or in the names of any relative, carrying on any of the following business, namely :

- i) Generation, transmission, distribution or supply of electricity.
- ii) Manufacture, sale or supply of any fuel for generation of electricity.
- iii) Manufacture, sale, lease, hire or otherwise, supply or dealing in machinery, plant, equivalent, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity and.
- iv) Any entity providing professional services or any of the business referred to in clause (1). (ii) and (iii) above.


C) Letter of willingness to resign his/her present post and to join as Chairman in UPERC, if selected.

D) Declaration in the form of undertaking to be submitted along with the application on the following points:

- i) That she / he does not have any financial or other interest which is likely to affect prejudicially her / his functions as Chairman, UPERC.
- ii) Whether any criminal case has been registered against applicant?
- iii) Whether applicant has been charge sheeted for any criminal offence? If yes, the details thereof.
- iv) Whether the applicant has been convicted by any competent court for any criminal offence? If yes, the details thereof.
